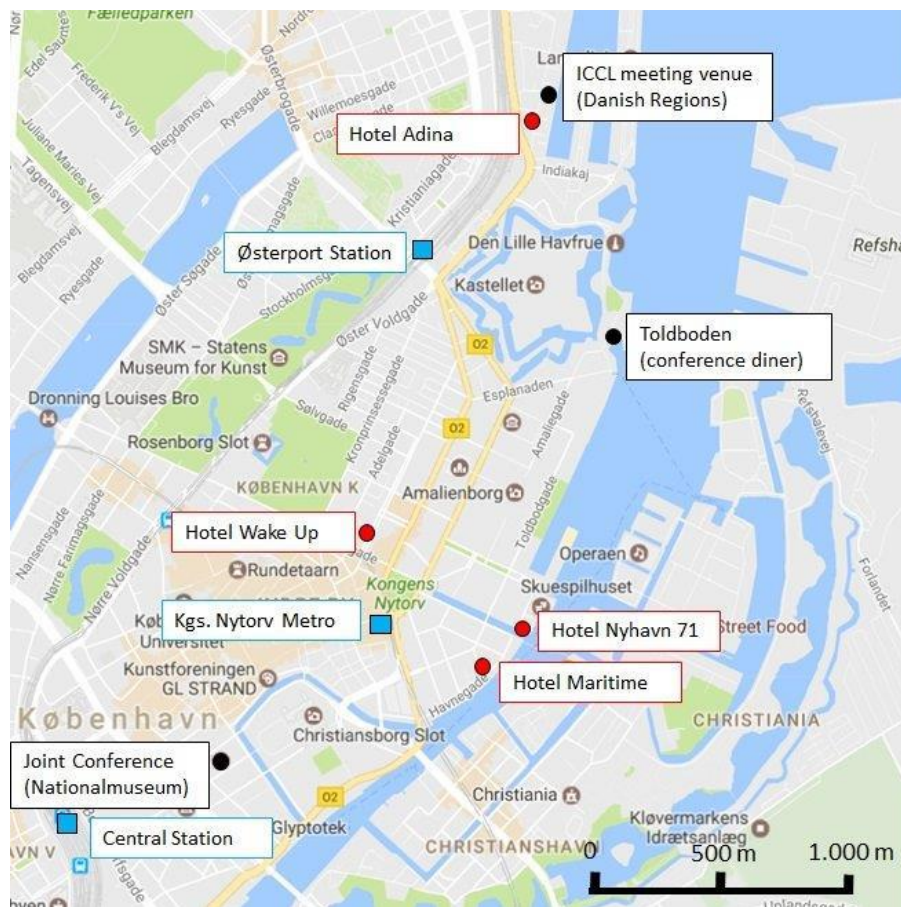

For international delegates traveling by air, you can get to the City centre by either train, metro or taxi. A taxi cost approximately 200 kroner to the city centre (€ 25).

For train, take the train towards “Helsingør” and get off at your convenience at either the Central Station or Østerport Station.

For Metro, both lines can be used. Get off at Kongens Nytorv (Kgs. Nytorv). It takes around 15 minutes.
